13. Summary of my Activities and Future Plans

Over the past two decades, my scholarship has focused on stress, trauma, and resilience among individuals, families, and communities living under conditions of political violence, social exclusion, and cumulative adversity. My doctoral work examined fatherhood under security threat, and my postdoctoral training in community mental health further broadened my perspective on trauma and mental health in community settings.

My empirical work spans multiple populations and contexts, including individuals and families living under continuous security threat, with particular attention to gendered aspects of fatherhood and family resilience, and Arab-Palestinians coping with individual, familial, and social traumas such as child abuse, discrimination, and racism.

I have published extensively in high-impact, peer-reviewed journals (e.g., *Psychological Trauma: Theory, Research, Practice, and Policy*; *American Journal of Orthopsychiatry*; *Journal of Family Studies*; *Journal of Social Policy*), positioning my research within the international discourse on trauma, intersectionality, and resilience. A central contribution of my work is the development of an ecological, intersectional perspective on traumatic stress that links individual symptoms with social structures, gendered expectations, and minority status, with particular attention to marginalized communities in Israel.

My research has been consistently supported by competitive national grants, reflecting its scientific merit and policy relevance. As PI and Co-PI I have received major funding from the Ministry of Science and Technology, the National Insurance Institute, and others, for projects such as the long-term consequences of child abuse among Arab young women, Arab students' success in higher education, gender- and culture-sensitive social policy, the psychosocial consequences of Covid-19 in Arab society.

These funded projects have been conducted in close collaboration with colleagues at Ruppin Academic Center, particularly Dr. Haneen Elias and Dr. Raghda Alnabilsy, as well as with external partners such as Prof. Marc Gelkopf and Prof. Lia Levin. Together, these collaborations have helped to advance trauma research in Israel with a particular focus on minority populations, gender, and socio-political context.

Within Ruppin Academic Center, my roles combine research leadership, program development, and intensive teaching and supervision. Since October 2025 I serve as Head of the Interdisciplinary Research Center for Advancing Mental and Social Health, which aims to lead innovative, practice-oriented research through partnerships with health, welfare, and community organizations. The Center's vision is to promote mental and social health by advancing evidence-based best practices, resilience, and equity for socially vulnerable populations, and to position Ruppin as a national hub connecting academia and the field in trauma-informed and context-sensitive work.

In parallel, I teach core courses at BSW and MSW levels—including “*Trauma, Resilience and Growth*”, “*Families under Stress and Trauma*”, “*Ecological Perspectives of Traumatic Stress Situations*”, and “*Social Work with Men under Crisis and Stress*”—and lead an MSW research seminar. In recent years I have also contributed to the development of the MSW specialization in trauma and resilience. I have coordinated first-year studies, chaired the Admissions Committee, and served on key departmental and institutional committees, thereby contributing to curriculum development, student support, and the strategic advancement of social work education at Ruppin Academic Center.

At the international level, I serve on the editorial board of *Psychological Trauma: Theory, Research, Practice, and Policy*, a leading APA journal that shapes global discourse on trauma and its psychological, clinical, and policy implications. In this role, I review manuscripts and help uphold rigorous standards for empirical and conceptual work in trauma studies.

My field activity is deeply anchored in trauma-informed and rights-based practice. I provide ongoing supervision and consultation to social workers, managers, and multidisciplinary teams in key human rights and community organizations, including Mesila, The Hotline for Refugees and Migrants, Kav LaOved and others. I also deliver

invited lectures and workshops for governmental ministries, NGOs, and professional associations on shared traumatic reality, secondary traumatic stress, self-compassion, trauma-informed education, and trauma-informed organizational practice, thereby contributing to capacity building and system-level resilience across Israel's welfare, health, and educational systems.

Looking forward, I intend to deepen and expand my research on stress, trauma, and resilience among marginalized groups in Israel, continuing to integrate personal, familial, and structural dimensions. Current and planned projects include qualitative and mixed-methods studies on men's experiences of war-related trauma and gendered expectations and trauma experiences and coping among autistic young adults and their families. I plan to further develop an interdisciplinary research agenda through the Interdisciplinary Research Center for Advancing Mental and Social Health, leveraging internal and external grants to build larger longitudinal and intervention studies that can inform national policy and practice.

In teaching, my goals are to continue integrating trauma-informed, experiential, and reflective pedagogy into BSW and MSW curricula, to expand supervision of MA and PhD theses in the areas of trauma, resilience, and gender, and to develop new courses on trauma-informed organizations and practice with men in crisis.

In the public arena, I aim to strengthen my engagement in professional and media discourse—through policy-relevant publications, participation in national committees, and continued collaboration with NGOs and government bodies—so that research conducted at Ruppin will translate into concrete improvements in services, policies, and public understanding of trauma and mental health in Israel.

My roles within the Ruppin Academic Center are rooted in a wider commitment to driving positive, lasting change for individuals and society as a whole. My research, teaching, and field practice trajectories are designed to mutually reinforce one another, creating a coherent agenda that advances trauma-informed, equity-oriented social work in Israel.
