I. <u>Summary of my Activities and Future Plans</u>

My research and publications focus on marginalized and excluded populations and minorities, particularly ethnic and gender exclusion, such as Arab women, young Arab women victims of domestic violence, children and adolescents exposed to abuse in Israel, students in academia from minority groups, and the LGBTQ community.

In 2011 my first science book was published in Arabic and distributed throughout the Arab world. The subject of the book - *Women and their bodies: The guide to women's health, bodies, and sexuality, (women to women).* The book is the culturally coordinated version of the international book -Our Bodies, Ourselves of Boston women, booklet that dared to address sexuality and reproductive health, including abortion. The book Received a title *"Women's Health Hero 2011"* by Women and their bodies and OBOS NGO. The title was given as a reward for writing and editing of the book "women and their bodies" in Arabic. The book was published in 2011 by nongovernmental organization Women and Their Bodies, and since thin it is distributed online free to the entire Arab world.

I would like to further investigate the problem of violence in Arab society in the socio-cultural and socio-political contexts of Israel. For example, I aim to explore the personal and interpersonal processes violent Arab men go through and explore the subject of violence against Arab children in Israel. Furthermore, I would like to continue my research of life experiences of victims of domestic violence of different national, ethnic, and class groups in Israel.

I also aim to delve into investigating the social, cultural, class, and socio-political contexts in the life experiences of women and youth victims of violence in various groups in Israel. The goal to which I aspire is to develop an innovative knowledge domain in subjects such as ethnic, social, cultural, political, and class contexts in Israel and their connection to social work practice.

Another area of research that I am focusing on is Arab adolescent girls in Israel, between normative development and youth at risk. This knowledge will allow a more suitable treatment for Arab girls and Arab young women in Israel. In July 2017, I was awarded a research grant by the National Insurance Institute of Israel, for a project entitled "The Long-Term Consequences of Child Abuse among Arab Young Women in Israel", in collaboration with two colleagues.

In November 2018, I was awarded another research grant by the National Insurance Institute of Israel, for a project entitled "Promoting marginalized young women's integration into post-secondary education: Identifying barriers and resources", in collaboration with two colleagues.

Another research that won a competitive grant from the Ministry of Science and Technology on the subject "Gender and socio-cultural adequacy of public social policy for assisting Arab young women in Israel".

In addition, I am working on two studies on the integration into higher education and success of young women and men from disadvantaged populations. The studies focus on better understanding difficulties and barriers to acquiring higher education in Israel. The aim of these studies is to gain better theoretical and practical knowledge of the integration into higher education and success of young women from Arab society, young women from the periphery of Israel, and students in Israeli academia.

In light of the COVID19 crisis, I am collaborating with two colleagues on investigating the psycho-social implications of the crisis on Arab society in Israel, which was awarded a research grant from the Ministry of Science and Technology.

My studies were awarded grants from the National Insurance Institute of Israel, by the Ministry of Science and Technology and from the Planning and Budgeting Committee (PBC), The Council for Higher Education (CHE).

During my academic teaching, I have acquired a lot of theoretical and practical knowledge in teaching and training social workers and students of social work in a multicultural environment. Moreover, I teach an innovative academic course for five years entitled: *From theory to practice in violence intervention and treatment in collectivist societies: The case of Arab society in Israel*, in Arabic, at the Ruppin Academic Center. This innovative course includes social interventions with Arab society in Israel, which is based on context-informed teaching of Arab students who come from an ethnic minority society and suffer from gender-based marginality. The course is accompanied by

research and documentation for academic publications. In addition, for several years I have served as a member of professional forums of professional societies and state institutions promoting policy in my area of expertise as a contribution to society in Israel.

Alongside international academic publications, I publish research reports to professional forums and policy makers in order to promote the services and practice around the population I research, and to contribute research knowledge to the field.

Finally, as part of my role as Academic head of the Arab students' unit at the dean of student since 2014, I led a process of building an aid unit for students from the Arab society in Ruppin, setting up a steering committee on the subject. This process has led to an increase in the number of students from the Arab society in Ruppin, the establishment of an assistance unit "Marssa" that provides counseling, mentoring, academic, emotional support services that help integrate and succeed in the academic teaching. The work in the assistance unit is accompanied by research evaluation and documentation for academic publications.
