13. Summary of my Activities and Future Plans

My perspectives and insights have developed over the years against the background of my identity as a woman, member of a minority group, social worker, educator, senior lecturer, and head of a social work department. Moreover, as a researcher focusing on at-risk young adults in Arab society from a context-informed perspective, I highlight the close connection

between practice, education, and research in social work.

My practice in the field of social work with women who are victims of violence and men who are perpetrators of offenses has exposed me to marginalized populations. As a result, I have developed a strong aspiration to research marginalized minority young adults who have experienced child abuse. Building on this background, my subsequent research work has been grounded in the theories that guide my approach: emerging adulthood, context-informed perspectives, and resilience theories.

As a young researcher, I was awarded several competitive research grants. I served as Principal Investigator (PI) on a project entitled "The Long-Term Consequences of Child Abuse among Young Arab Women in Israel," funded by the National Insurance Institute of Israel, and as Co-Investigator (CI) on multiple projects supported by the Ministry of Science and Technology: a) "Arab Students' Success in Higher Education in Israel"; b) "Gender and Socio-Cultural Adequacy of Public Social Policy for Assisting Young Arab Women"; and c) "Psychosocial Consequences of the COVID-19 Outbreak for the Arab Population in Israel." My research has focused on young adult Arabs, exploring their coping strategies in the face of adversity and the barriers they face in accessing formal support. These issues were examined from the perspectives of both the young adults themselves and the professionals who work with them. Through these studies, I have deepened my understanding and expanded my scholarly writing on the intersection of various contextual factors in the lives of marginalized young adults specifically, their cultural context (Arab-patriarchal society), the social context (women's status in Arab society), and the socio-political context (majority-minority relations and social exclusion). These investigations have also illuminated the influence of these contexts on the lives and functioning of these young adults, as well as on

the social policies that affect them.

In 2021, I was awarded a competitive research grant by the Israel Science Foundation (ISF) to conduct a study entitled *"Risk and Resilience in the Transition to Adulthood Among At-Risk Young Adult Arabs in Israel: A Context-Informed Perspective."* Through this research, I aim to advance the conceptualization of risk situations experienced by young Arab adults, with the objective of understanding these risks within this population's intersecting social, cultural, and political contexts. A deeper understanding of these context-informed risk situations in Arab society will inform the adaptation of prevention and intervention programs tailored to at-risk young adult Arabs. To date, this research has yielded five peer-reviewed academic articles.

Due to my research achievements and the accumulation of a practical, context-aware perspective in the field of emerging adulthood within Arab society, I have become recognized as an expert in this area. Consequently, I was invited to supervise one postdoctoral fellow and three doctoral students at the Bob Shapell School of Social Work, Tel Aviv University. The work of the postdoctoral fellow focused on "Minority Identity-Informed Social Work: Social Workers' Perspectives on Risk Among Young Adult Arabs in Israel." The dissertations of the three doctoral candidates addressed the following topics: "Resilience During Emerging Adulthood Among At-Risk Arab Young Adults in Israel: A Context-Informed Perspective"; "Emerging Adulthood Among At-Risk Young Arab Adults: Their Perceptions of Risk"; and "Future Perception in Emerging Adulthood Among At-Risk Young Arab Women in Israel: A Context-Informed Perspective." In addition, reflecting my expertise in the area of emerging adulthood, I was offered the opportunity to teach a master's level course on "The Transition to Emerging Adulthood: Risks and Resilience" at the Ruppin

Academic Center, alongside a master's seminar course and supervision of master's theses on related topics.

In 2024, I was recognized for the importance of my research in the field of emerging adulthood by receiving a research grant from the President's Fund at the Ruppin Academic Center. As a result of this grant, I successfully led a quantitative study completed in March 2025 on the loss of resources among young adult Arabs ($n = 964$) following the October 7th war. Simultaneously, I led a qualitative study that examined the future orientation of young adult Arabs in the shadow of the war.

Throughout my research work, it has been important for me to maintain a strong commitment to social missions. Therefore, I actively collaborate with a broad range of service providers, including government agencies and civil society organizations. I am frequently invited to deliver professional lectures addressing the transition to young adulthood within intersecting contexts, such as probation services, community courts, and various organizations serving young adults. For example, I served as an external consultant to BDO (Assurance, accounting, tax and advisory services), specializing in service provision for young adults from minority groups.

I was also elected in 2024 to lead the Department of Social Work at Ruppin Academic Center through a selection process involving 10 faculty members from the Department. I received the support of nine colleagues, reflecting strong confidence in my ability to manage the Department. I am highly dedicated to the position and cognizant of the significant responsibility that I bear in this role.

In recognition of my scholarly contributions and achievements in the field of transition to young adulthood among at-risk young adults, I was invited to serve as a member on the

executive board of two national organizations. The first is ESPAnet Israel (European network for social policy analysis), which promotes research in the field of social policy in Israel and aims to serve as a unique platform for researchers, policymakers, and civil society activists involved in the shaping and implementation of social policy in the country. The second is “Be-Atzmi,” a social organization that has been operating for 30 years to promote employment integration among marginalized and underprivileged populations.

On an international level, I am developing professional connections and exploring potential collaborations with researchers in Switzerland who are investigating emerging adulthood among care leavers. I am also a member of the Special Interest Group on Social Work with Adolescents, representing the European Social Work Research Association. Additionally, as a faculty member and Head of the Department of Social Work at Ruppin Academic Center, I am a member of the International Association of Schools of Social Work (IASSW).
