Summary of my Activities and Future Plans

My primary themes driving my activities encompass the following:

1. Nursing Education with an emphasis on ethical and moral aspects, development of teaching programs, and improvement of learning methods.

I firmly believe that cognitive intelligence alone is insufficient in adequately preparing nursing students for the challenges they will encounter in the dynamic world of healthcare. As a nursing educator, I believe that it is our responsibility to address this gap in the nursing curriculum. Consequently, I initiated research centered on the topic of "**Emotional Intelligence level and its impact on the level of educational achievements among nursing students**". The primary objective of this research was to demonstrate the influence of Emotional Intelligence on nursing students' academic success, encompassing both theoretical and clinical aspects of their studies.

Another critical focus of my work in nursing education is to positively shape student attitudes and empower them on contemporary issues, such as their outlook towards suicidal individuals and battered women. A recent study, "**Factors Influencing Nursing Students' intention to practice sexuality education in their professional work,**" which has been published, explores the empowerment of nursing students in

this domain. The study aimed to identify the factors affecting nursing students' willingness to embrace the role of a sexuality educator in their practice. As a result of this research, we concluded that enhancing nursing students' self-efficacy on this subject is pivotal in increasing their intention to apply it in their future careers. As a direct outcome of this study, I had the privilege of spearheading the introduction of a novel course within the nursing core curriculum, centered around the pivotal subject of sexuality.

Additionally, I am deeply interested in investigating moral courage and its dimensions among nursing students and professionals, seeking to further enhance the ethical fabric of the nursing profession.

2. Nursing professionalism, focusing on quality nursing care, advocacy for human rights, and empowerment of patients.

Presently, I am engaged in collaborative research, with a colleague, on the phenomenon of obstetric violence. I believe that in the nursing profession, which is deeply rooted in caring sciences, it is imperative to acknowledge the role nurses play in addressing this global issue and promoting the rights and empowerment of women receiving obstetrics and gynecology treatments. Recently our study on "The experience of pregnancy and childbirth overshadowed by obstetric violence and structural barriers of the Israeli health system from the perspective of Arab and Jewish women" was published. The aim of this study was to give a voice to Arab and Jewish women in Israel who had suffered obstetric violence during various stages of fertility treatments, pregnancy and childbirth. In addition, to learn from the women about their experiences of obstetric violence subject to the barriers of the Israeli health system, and their recommendations of possible solutions. The study underlines the unique gender, social and cultural context in Israel concerning pregnancy and childbirth, and was based on the feminist approach that strives to promote human rights, and eradicate phenomena of gender-related, patriarchal and social structures

Currently, we are diligently preparing a second article titled "Obstetric violence consequences and coping strategies: Insights from the perspectives of Arab and Jewish women in Israel" for submission.

Moreover, I have been actively involved in a research group exploring the benefits of implementing "Birth Oriented Therapy" (BOT) as a valuable tool to enhance the emotional sensitivity of nurses, particularly in the fields of gynecology and obstetrics. This approach aims to empower patients by providing more attentive and compassionate care.

As a passionate advocate for caring as the core of nursing, I actively initiate and participate in research focusing on phenomena that directly oppose the principles of compassion, such as bullying and violence directed at healthcare personnel, nursing students, and patients. One such ongoing research pertains to obstetric violence, where I am emphasizing the urgent need to reestablish caring as a fundamental aspect to combat this issue effectively.

In summary, my dedication to nursing education, ethical considerations, professionalism, and patient empowerment forms the bedrock of my research and advocacy work. Through these endeavors, I aim to contribute positively to the advancement of nursing education, nursing practice and the overall well-being of patients and healthcare providers alike.
